The removal of the contentious emergency access exiting into The Street, has resulted in only one access which is essentially a 'cul de sac within a cul de sac'. The current site, if permission is granted and including the additional properties in Vicarage Lane (cul de sac), will exceed the max number of homes (50) for a cul de sac situation and therefore the need for an additional emergency access is essential. In addition, this is does not take into account emergency evacuation of the care home. Parking spaces allotted to the care home (18) is inadequate.
